### **Unlocking Development Finance (2019-20)**

- National Finance Institutions and Policy discussions

This course introduces different aspects of finance – looking at the fundamental premises on which the world of finance is systematically built, understanding the role of financial institutions beyond lending/banking, addressing the contemporary issues related to finance in India and critically looking at the gaps in governance, transparency and accountability in finance / of financial institutions. The course strives to make finance palatable and highlight the integral nature of finance in all walks of our lives.
