

FOUNDER OF THE COLLEGE



Late Shri Brij Krishan Chandiwala 1900 - 1986

Shri Brij Krishan Chandiwala, the founder of Janki Devi Memorial College, was born in 1900 in a reputed family. As the third son of a flourishing silver merchant's family, there were no domestic pressures on him to join the family business. After the early demise of his wife, he joined the freedom movement led by Gandhiji.

His mother's entreaties to remarry fell on deaf ears. Brij Krishanji became a true disciple of Gandhiji. He went to jail several times during the freedom movement. When Gandhiji started the agitation against the Salt Law, Brij Krishanji took an oath to give up salt and sugar for life. He was forced to break this vow in the last days of his life on health grounds.

At Gandhiji's behest, he had a prayer temple built in a Harijan Colony. He started the Delhi chapter of the Bharat Sewak Samaj, an organization for the upliftment of the underprivileged.

In 1959, Shri V.K.R.V. Rao, the Vice-Chancellor of Delhi University, appealed to the wealthy philanthropists of the city to come forward to open girls' colleges in Delhi. It was then that Brij Krishanji, who had no children of his own, donated all his inherited wealth to the family trust, Shri Banarsidas Chandiwala Sewa Smarak Society, in the memory of his late mother, Smt. Janki Devi. Till his very end, this great visionary remained our mentor and guide.

Today Brij Krishanji is remembered for his social service and closeness to Gandhiji. When Nathuram Godse fired that fatal shot, Bapu fell backward into the arms of Brij Krishanji, who was sitting right behind him.



Message from the Principal



I warmly welcome you to Janki Devi Memorial College, University of Delhi! Implementing these objectives is an entire team constituted by the Management (with a highly motivating Trust body), some of the finest Faculty of the University, a proactive non-teaching staff and extremely dynamic Alumnae. JDMC is proud of the disciplined way in which classes are held in this college with regular tutorials as well as remedial classes. The University rules regarding internal assessment are strictly followed by us and we do not believe in compromising with them. There is transparency and a democratic approach in all that is undertaken within the college so that students can express their grievances / suggestions through various means such as the monthly student faculty meetings, the feedback forms and the open door policy followed by the college at all levels, Faculty, Admin Staff and Principal. The central location of the college, the ease with which one can access it on the Metro line and the impressive building with lush greens, make it a home away from home. The classrooms are clean, comfortable and well ventilated; the premises contain a common room and a medical room with a sanitary napkin vending machine; an open air auditorium; a bank; an attractive cafeteria; computer laboratories; audio visual rooms; a photo copying centre as well as a Mother Dairy booth. The grand library houses over a lakh books and is fully computerized. The most exciting development is that we are on the verge of completing our Hostel and this will cater to a hundred plus students!

We have won a Green Campus Award, Best Managed College of the Year Award and Girl Centric Tertiary Education and Training award from WAGE in recent years. The college is well known for its many environmentally sound practices such as rain water harvesting, solar panelling and the development of the eco zones on campus. The ramps, the Braille sections of the library, the tactiles on the floors and the elevator are some of the ways in which we assist the physically challenged. Not only in terms of intellectual and physical nurturing, the college is very concerned about the emotional well being of its students. So we have Counselling services of varying kinds provided to the students with a Visiting as well as on call Counsellor along with the workshops conducted for emotional well being through the agency Zyego. Those who are economically marginalized are assisted through fee concessions and scholarships by us. Students of this college not only receive the best of scholarly training but have ample opportunities to participate in a wide range of extra and co-curricular activities through the various clubs and Societies such as sports, NSS, NCC, Western and Classical dance and music, debate, photography, creative writing, theatre, investment cell and so many more. The active Placement Cell of the College works tirelessly to provide placements/internships to our students. The college is a Centre for the Non collegiate Women's Education Board as well as the School of Open learning. The Janki Devi Vocational Centre is another asset of the college. There can be no better place than JDMC for one to learn how to become a global citizen with the ability to contribute to society meaningfully. I wish you the very best of luck. God bless you.

National Accreditation and Assessment Council (NAAC) Peer Team Visit to JDMC:

The NAAC Peer team consisiting of Prof. Vaikunthan (Chair), Prof. Venkatramani and Dr. Lalitha (members) visited the college on 28th and 29th August, 2017. This visit was the culmination of the collective efforts that had been made over two years by the management, faculty members, administrative staff, students, their parents and the alumni of JDMC. The process involved a lot of hard work and made us introspect about JDMC's unique strengths and lacunae and rethink some of our educational strategies. JDMC was the first college in Delhi University to be assessed under the new, revised system of NAAC, in which only 20% weightage is given to the peer team's inputs, thereby making the process

of assessment and accreditation more objective and transparent. Thus, the award of B++ given to the college by NAAC has spurred us to work harder and improve our score when the visit takes place again after five years.

महाविद्यालय विशिष्टताएँ

महाविद्यालय का कार्य दिवस और समय: महाविद्यालय, सोमवार से शनिवार तक सप्ताह में 6 दिन खुलता है। कक्षाएं प्रातः 9.00 बजे से प्रारंभ होती हैं और प्रातः 11.45 बजे से 12.05 बजे तक के अल्पविराम (ब्रेक) सिहत शाम आठवें कालांश (पीरियड) के साथ समाप्त होती हैं। सभा असेंबली प्रातः 11.45 बजे से 12.05 बजे तक हर दिन आयोजित की जाती है। बुधवार को विभिन्नु पाठ्येतर गतिविधियां हेतु प्रातः 11.15 बजे से 12.15 बजे तक विशेष लंबी सभा आयोजित की जाती है। इन सत्रों में उपस्थिति अनिवार्य है।

पहचान पत्र: नए शैक्षणिक सत्र (2018—2019) हेतु महाविद्यालय के पुनः खुलने पर, सभी विद्यार्थियों को संस्थान वास्तविक विद्यार्थी के रुप में उनके परिचय को साबित करने के लिए फोटो और आवश्य क विवरण सिंहत पहचान—पत्र दिया जाएगा। सभी विद्यार्थियों से अनुरोध किया जाता है कि मूल शुल्क—प्रति के साथ कार्यालय से संपर्क करे और सूचित तारीखों को अपना पहचान पत्र प्राप्तर करें। सभी विद्यार्थी से अनुरोध है कि वे प्रत्येक दिन अपना पहचान पत्र साथ लाएं और मांग करने पर दिखाएं। विद्यार्थी से आवेदन पत्र प्राप्त कर और बैंक में रु. 50 के भूगतान पर महाविद्यालय द्वारा जारी प्रतिलिपि (इप्लीकेट) पहचान पत्र प्राप्त किया जा सकता है।

समय सारणी : सत्र हेतु समय—सारणी की प्रतियां वितरित की जाएंगी और प्रथम वर्ष के विद्यार्थियों को उन्मुखीकरण दिवस (ओरिऐंटेशन डे) पर जब वें अपने संबंधित शिक्षक से मिलते हैं, स्पष्ट की जाएगी। समय—सारणी, महाविद्यालय की वेबसाइट के साथ—साथ नोटिस बोर्ड पर भी उपलब्ध है।

महाविद्यालय छात्रावास : जानकी देवी मेमोरियल कॉलेज इस साल कॉलेज में छात्राओं के लिए कृष्णा छात्रावास क निर्माण मील का पत्थर है। इस छात्रावास का शुभारंभ आगामी अकादमी सत्र से सुचारु रुप से किया जाएगा। असल में यह बहुमंजिली इमारत, महज़ एक छात्रावास नहीं बल्कि देश के अलग—अलग हिस्सों से आए छात्राओं के लिए घर से दूर एक सुरक्षित घर देने कोशिश है। लड़कियों का कॉलेज होने के नाते हमारी यह प्राथमिक और महत्वपूर्ण ज़िम्मेदारी है, उनकी सुरक्षा। हवादार कमरों से जुड़े बाथरुम, शानदार किचेन और मेस के साथ—साथ रीडिंग रुम और कॉमन रुम यानी पूरे छात्रावास का निर्माण छात्राओं को बेहतर वातावरण देने के उदेश्य से किया गया है यहाँ कुल 105 सीट उपलब्ध है, जिसमें दिव्यांगों को भी शामिल किया किया गया है। दिव्यांगों को ध्यान में रखते हुए एलीवेटर की सुविधा दी गई है। छात्रावास से जुड़ी ज्यादा जानाकरी के लिए प्रॉसपेक्टस देखें।

महाविद्यालय पुस्तकालय: महाविद्यालय के पुस्तकालय संग्रह में शैक्षणिक और सामान्य दोनों मिलाकर, एक लाख से अधिक पुस्तकें और एक हजार पत्रिकाएँ (जर्नल) हैं। यह दिल्ली विश्वविद्यालय की प्रथम पूर्णस्वचालित पुस्ताकालयों में से एक है और निःशुल्क फोटोकापी और इंटरनेट सुविधा उपलब्ध करवाती है। नए विद्यार्थी पुस्तकालय पहचान—पत्र जारी करवाने हेतु अपने पहचान—पत्र के साथ पुस्ताकालय स्टाफ से संपर्क करें।

चिकित्सा कक्षः विद्यार्थी और स्टाफ के प्राथमिक उपचार और अन्य आपातकालीन आवश्यकताओं की जरूरतें पूरी करने के लिए सभी कार्य दिवसों में प्रातः 10.00 बजे से 12.00 बजे तक चिकित्सा कक्ष खुला रहेगा। प्रभारी चिकित्सक, प्रो. डॉ. सुदेश कुमार चुग, एक वरिष्ठ सलाहकार, फिजिशियन, हृदय रोग विशेषज्ञ, मधुमेह चिकित्सक, जठरांत्र चिकित्सक और रनायु विशेषज्ञ हैं।

कंप्यूटर प्रयोगशाला : हमारी प्रथम प्रयोगशाला का उदघाटन प्रो. श्री राठौड़ द्वारा दिनांक 28.10.2005 को किया गया था। अब, हमारे पास विद्यार्थियों और संकाय के प्रयोग हेतु इंटरनेट कनेक्टिविटी सहित लगभग 130 कंप्यूटरों की तीन कंप्यूशटर प्रयोगशालाएं हैं।

सभागार : महाविद्यालय के पास प्रकाश और ध्विन कक्ष सिहत नया अदभुत उन्मुक्त सभागार है। यह मेजबान कार्यक्रमों को एक अलग सौंदर्य प्रदान करने वाला हरे—भरे वातावरण के बीच स्थित है। यहां 2000 से अधिक लोगों के बैठने की सीटें हैं और सज्जा गृह (ग्रीन रूम) भी हैं।

कैफेटेरिया: महाविद्यालय के पास एक विशाल कैफेटेरिया है जो विद्यार्थियों और स्टाफ को उचित दर पर नाश्ते की विविधता उपलब्ध करवाता है। प्राचार्य, बर्सर, स्टाफ काउंसिल सचिव, स्टाफ एसोसिएशन के सचिव, स्टाफ सलाहकार और छात्र संघ के अध्यक्ष से मिलकर बनी कैंटीन समिति की देख—रेख में कैफेटेरिया चलाया जाता है।

महाविद्यालय बगीचा : महाविद्यालय का बगीचा गर्व का निरंतर स्रोत हैं। हम अलग—अलग श्रेणियों में कई पुरस्कार जीत चुकें हैं। रॉक गार्डन ने विश्वविद्यालय पुष्प प्रदर्शनी में प्रथ्म पुरस्कार जीता है।

जनसूचना अधिकारी कक्ष: महाविद्यालय का जनसूचना अधिकारी महाविद्यालय समय के दौरान अपने कार्यालय में उपलब्ध होता है। उनका कार्यालय छात्र संघ कक्ष के निकट स्थित है।

विद्यार्थी संघ: निर्दिष्ट स्टाफ सलाहकारों द्वारा दिशा—निर्देशित सक्रिय छात्र संघ है। यह नियमित रूप से सांस्कृतिक कार्यक्रम, संगोष्ठियों और कार्यशालाओं, उनमें से सबसे रोमांचक महाविद्यालय का वार्षिक अंतरमहाविद्यालयी सांस्कृतिक उत्सव सिम्फनी का आयोजन करता है। संघ के सदस्यों का चुनाव वर्ष में एक बार किया जाता है और वे, अगर विद्यार्थियों को कोई समस्या हो तो उनकी मदद करते हैं। छात्र संघ 4 निर्वाचित सदस्य से मिलकर बना हैद्य अध्यक्ष, उपाध्यक्ष, सामान्य सचिव और कोषाध्यक्ष साथ ही 3 मनोनीत सदस्य जिनमें नाटक सभा के सचिव, वाद—विवाद सभा सचिव और संगीत और नृत्य सभा सचिव शामिल हैं।

एल्युमनी एसोसिएशन: हमारे स्वर्ण जयंती के अवसर पर, हमने अपनी एल्युमनी के लिए एक व्यापक डेटाबेस बनाया जिन्होंने खुद को अकादिमक और व्यावसायिक रुप से साबित किया है। हमारी शानदार एल्युमनी में शिक्षाविद, वकील, दफ्तरशाह और व्यसवसायी शामिल हैं। वर्तमान में, उनमें से कई शहर—भर में विभिन्न शैक्षिक संस्थानों के प्रमुख हैं।

सह-पाठयक्रम और पाठ्येतर गतिविधियां : सभी छात्र महाविद्यालय छात्र संघ के सदस्य हैं और संघ की गतिविधियों में सक्रिय रूप से भाग लेने की उनसे आशा की जाती हैं। हर विद्यार्थी के लिए प्रत्येक समूह में से कम से कम एक गतिविधि का चयन करना आवश्यक है।



COLLEGE HIGHLIGHTS

COLLEGE WORKING DAYS AND TIMINGS: The College observes a six day week from Monday to Saturday. Classes commence at 9.00 a.m. daily and ends at VIIIth period, with a break between 12.00 noon to 12.20 p.m. On Wednesdays, there is a special long assembly from 11.45 a.m. to 12.45 p.m. for various extra-curricular activities. Attendance in these sessions is mandatory.

IDENTITY CARD: After the college re-opens for the new academic session (2018-2019), all new students will be given an identity card with a photograph and necessary details to prove their credentials as a bona-fide student of the institution. Every student will be required to contact the office with the original fee slip and collect the identity card on notified dates. All students are required to carry the I-card to the college everyday and produce it on demand. Duplicate Identity card will be issued by the college on receiving an application from the student and on payment of Rs.50/- in the Bank.

TIME TABLE: Copies of the time-table for the session will be distributed and explained to the first year students on the Orientation Day when students meet their respective teachers. Time Tables will also be available on the college website as well as notice boards.

COLLEGE HOSTEL: One of the most significant milestones is the construction of Krishna Hostel, which will be inaugurated and made available to the students in 2018. This multi-storey building in the campus will provide a safe home for students coming from different parts of India. As a women's college, students' safety has been the primary concern driving this project, which can house more than a hundred students. The airy rooms with en suite bathrooms, well equipped kitchens and mess area, reading rooms and the common room have been designed to give the students a good residential ambience. For more details, please refer to the prospectus that has been specially printed for the hostel.

COLLEGE LIBRARY: JDMC's library is a repository of over one lakh books and one hundred journals, both academic and general. It is among the first fully automated libraries in the Delhi University and provides photocopying and free internet facilities. Newly admitted students should contact the library staff with their Identity card for the issue of library cards.

MEDICAL ROOM: JDMC's medical room will be open on all working days from 10.00 am. - 12.00 p.m to cater to first aid and other emergency requirements of the students and staff. The doctor in-charge, Prof. Dr. Sudesh K. Chugh, is a Senior Consultant, Physician, Cardiologist, Diabetologist, Gastroenterologist and Neurologist.

COMPUTER LABS: Our first computer lab was inaugurated by Professor Shirin Rathore on 28/10/2005. Now, we have three computer labs with nearly 130 computers with internet connectivity for the use of students and faculty.

AUDITORIUM: JDMC has a unique open air auditorium with a fully equipped lights and sound room. Situated amidst lush green surroundings that lend a special charm to the functions it hosts, it seats more than 2000 people and also has green rooms.

CAFETERIA: The College has a spacious cafeteria that offers a wide variety of snacks to students and staff at reasonable rates. The cafeteria is supervised by a Canteen Committee consisting of the Principal, Bursar, Staff Council Secretary, Staff Association Secretary, Staff Advisors and the President of the Students' Union.

COLLEGE GARDEN: The College gardens are a constant source of pride. We have won many prizes in different categories. The Rock Garden has won the 1st prize at the University Flower Show.

PIO's ROOM: The Public Information Officer of the college is available during college hours. Her office is located near the Students' Union Room.

STUDENTS' UNION: JDMC has an active Students' Union guided by designated Staff Advisors. It regularly organises cultural shows, seminars and workshops, the most exciting of them being 'SYMPHONY', the annual inter-college cultural festival of JDMC. Union members are elected once a year and help students, who have any problems. The Students' Union comprises of 4 elected members - President, Vice President, General Secretary and Treasurer and 3 nominated members: Drama Club Secretary, Debate Club Secretary and Music & Dance Club Secretary.

ALUMNAE ASSOCIATION: On the occasion of our Golden Jubilee, we created an extensive database of our alumnae, who have proved themselves academically and professionally. Our illustrious alumnae include academics, lawyers, bureaucrats and professionals. Many of them are currently heads of various educational institutions all over the city.

CO-CURRICULAR & EXTRA-CURRICULAR ACTIVITIES: All students are members of the JDMC Students' Union and are expected to take an active part in the activities of the Union. Every student is required to opt for at least one activity from each group.

सह-पाठ्यक्रम गतिविधियों में शामिल

करियर अपॉरचुनिटी सेल: युवा महिलाओं को स्कॅलरशिप और इंटर्नशिप का अवसर प्रदानकर उनमें आंत्रप्रेत्योरशिप स्किल्स बढ़ाने की कोशिश का नाम है। इससे आत्मविश्वास तो बढ़ता ही है साथ ही उन्हें आर्थिक और व्यावसायिक तौर से भी मजबूत बनाया जाता है।

आंत्रप्रेन्योरिशप सेल–इमप्रेन्योर: की शुरुआत 2017 में की गई है, जिसका मक़सद है छात्रों की क्षमता के अनुसार नौकरी के अवसर प्रदान करना। इसके तहत सेमिनार का आयोजन किया जाता है जिसमें छात्रों को आंत्रप्रेन्योर बनने की दिशा में चर्चा की जाती है।

भारतीय कैडेट कोर (एन.सी.सी.) : एन.सी.सी. के कैडेटों ने शूटिंग, निशानेबाजी, ड्रिल और पंक्ति प्रतियोगिताओं में पुरस्कार जीते हैंद्य एन. सी.सी. कैडेटों ने गणतंत्र दिवस के शिविरों में भी हिस्सा लिया एन.सी.सी. के कार्यक्रम प्रतिवर्ष अगस्त में आरम्भ होते हैं और प्रमाण–पत्र परीक्षा के साथ मार्च में संपन्न होते हैं।

राष्ट्रीय सेवा योजना (एन.एस.एस.) : महाविद्यालय की एन.एस.एस. सोसायटी दिल्ले विश्वविद्यालय की एन.एस.एस. की ईकाई से सम्बद्ध है। एन.एस.एस. में पंजीकृत विद्यार्थी परियोजनाएं ले सकते हैं। जैसे रक्तदान शिविर, सामुदायिक सेवा, चिकित्सा सेवा आदि।

भारतीय खेल संगठन (एन.एस.ओ.) : महाविद्यालय का शारीरिक शिक्षा विभाग खेल संगठन चलाता है, जो दिल्ली विश्वविद्यालय खेल परिषद् से सम्बद्ध है। इसके अतिरिक्त हम विद्यार्थियों को प्रोत्साहित करते हैं कि वे योग, एरोबिक और तैराकी से जुड़ेंद्य हम अपने संकाय, स्टाफ और विद्यार्थियों में स्वारथ्य संबंधी जागरुकता बढाने के लिए एक पूर्ण सज्जित नई व्यायामशाला (जिम) बना रहे हैं। हम सभी विद्यार्थियों का स्वागत करते हैं कि वे एन.एस.ओ. से जुड़ें और हमारी विशेषज्ञता से लाभ उठाएं।

गांधी शिक्षा केंद्र : गांधी शिक्षा केंद्र विश्व में व्याप्त आतंक और साम्प्रदायिक हिंसा के विरुद्ध शान्ति और अहिंसामयी गांधीवादी दृष्टि की प्रासंगिकता पर ध्यान केन्द्रित करता है। इस शिक्षा केंद्र से जुड़नेवाले सभी विद्यार्थियों का स्वागत है।

CO-CURRICULAR ACTIVITIES INCLUDE

Career Opportunity Cell ensures that young women are trained to achieve their career goals through scholarships and internship opportunities to empower them financially.

Counselling Committee - The Psychological Counselling Cell: Janki Devi Memorial College has a two-pronged strategy to provide psychological counselling to students.

- a. The College has signed a Memorandum of Understanding (MOU) with ALS Wellness Network Pvt. Ltd, with the brand name 'Zyego' for online counselling. The services provided by Zyego are as follows
- 1. Counselling for students through an app
- 2. Face to Face counselling
- 3. Group therapy sessions
- 4. Personality Assessment using psychometric methods
- 5. Organizing workshops for students, faculty members and administrative staff
- 6. Events which promote wellness, cohesion and healthy work environment.

b. In order to provide counselling at personal level, the college has also sought the services of Ms. Sania Bedi, Counselling Psychologist. She comes twice a week to the college to help students deal with a range of problems related to career, family, bullying, peer pressure, body image, self-confidence.

Entrepreneurship Cell- Impreneurs was started in January 2017 to help students evolve their employability potential. The cell has organised seminars on career planning and on the benefits of being an entrepreneur.

Enabling Unit / Equal Opportunity Cell aims at providing holistic education to the differently-abled students. Over the years, the cell has equipped these students with technical and add-on courses and arranged angel pro-pocket recorders to make them self reliant.

Gandhi Study Circle: The Gandhi Study Circle focuses on the relevance of Gandhian ideas of peace and non-violence in a world rife with terror and sectarian violence. All students are welcome to join this study circle.

National Cadet Corps (NCC): The NCC Cadets have won accolades in shooting, firing, drill and line competitions. NCC cadets also attend Republic Day Camps. NCC Programme begins in August and ends with the certificate exams held in March every year.

National Service Scheme (NSS): NSS society of JDMC is affiliated to the NSS unit of Delhi University. Students registered for NSS have to take up projects like organizing Blood Donation Camps, perform Community Service, Hospital Service etc.

National Sports Organisation (NSO): The Sports organisation is run by the Physical Education department of the college and is affiliated to Delhi University National Sports Council. Apart from encouraging our students to engage in yoga, aerobics and swimming, we organise various activities and Inter-departmental competitions for different sports to motivate and to raise health awareness among all. All students are welcome to join NSO and avail of our expertise.

Non-Collegiate Cell: The JDMC Centre for Non-Collegiate teaching is designed to teach students of B. A. Programme and B.Com courses of Delhi University. These courses enable continuation of higher education for those students who cannot attend regular college. Classes are held on Sundays and during holidays and vacations. Library facilities are provided to all students and recognised teachers of the University and colleges are appointed to teach the Non-Collegiate students.

Women's Development Centre (WDC): A Women's Development Centre is functioning in JDMC with the assistance from the Department of Women's Studies and Development Centre. It aims to promote, develop and disseminate knowledge regarding the role of women in the present social context.

बार्डोलेटर्स-द शेक्सपीयर सोसायटी : एक ऐसी थियेटर और स्ट्रीट प्ले सोसायटी जो हिन्दी और अंग्रेजी़ दोनो भाषाओं में नाटकों का मंचन करती है। इस संस्था में कॉलेज के तमाम विभाग के छात्रों की हिस्सेदारी होती है। बेहतरीन प्रर्दशन की वजह से बार्डोसलेटर्स को कई पुरस्कार भी मिल चुके हैं।

Bardolators- the Shakespeare Society consists of students from different departments. It is both a proscenium based theatre and street play society and usually performs bilingually in both Hindi and English. It has won numerous prizes and accolades at the inter-collegiate level.

Chetna - This society aims at stimulating the young minds with a passion for self discovery and gives them an opportunity to enhance their personalities.

Euphonie-The Western Music Society is highly popular among students and has won many prizes in numerous inter college competitions.

ADMISSION PROCEDURE 2018-19

All admissions shall be made according to the norms laid down by the University, respective departments and according to the number of seats available.

All students who qualify for the admission are supposed to be accompanied by their Parent/Guardian on the day of the admission. **Personal presence of the candidate is necessary at the time of admission.** In exceptional cases, permission may be obtained from the Principal in writing, stating reasons and authorising somebody to secure admission on her behalf.

ELIGIBILITY CRITERIA FOR ADMISSION TO UNDERGRADUATE COURSES

- Minimum Aggregate Marks 40% for B.A. Programme (36% for OBC category candidates) 45% for B.A. (Hons.)/B.Com (Hons.) (40.5% for OBC category candidates) The aggregate marks will be on the basis of one core language and the best of three elective subjects *in one of the following examinations:-
- (a) Senior School Certificate Examination Class XII of the Central Board of Secondary Education, New Delhi.
- (b) Indian School Certificate of the Council of Indian School Certificate Examination, New Delhi (Pass in 5 written subjects).
- (c) Any Examination recognised as equivalent to the above.
- (d) Intermediate examination of an Indian University or an Examination recognised equivalent thereto. (Pass in 4 written subjects).
- (e) Pre-University Examination, 2 years after 10 years of schooling of an Indian Board.
- (f) General Certificate of Examination of the U.K. (Pass with at least 5 subjects at 'O' level and at least two of them at 'A' level). These two 'A' level courses may either be chosen from the 5 'O' Level subjects or from outside this group prescribed by the University of Delhi.

Reservations

Reservation of Seats for Scheduled Caste/Tribe Candidates

- 22½ % of the total numbers of seats are reserved for candidates belonging to Scheduled Caste/ Scheduled Tribes (15% for Scheduled Caste and 7½% for Scheduled Tribes, interchangeable, if necessary).
- Relaxation to the extent of 5% in the minimum marks will be given to the candidates belonging to Scheduled Caste and Scheduled Tribes to determine their eligibility and merit for admission to the course concerned.
- In case, after giving 5% relaxation, the reserved seats still remain vacant, further relaxation would be given to the extent required in order to fill up all the reserved seats.(AC Resolution A88, 14.6.1983) (EC Resolution 157, 24.12.2001).

Note:SC/ST students who get admission under open merit will not be included in the reserved quota i.e. 22.5%.

The following are empowered to issue the requisite SC/ST certificate:

- (a) District Magistrate/ Additional District Magistrate/ Collector/ Deputy Commissioner/ Addl. Deputy Commissioner/ Deputy Collector/ 1st class Stipendiary Magistrate/ City Magistrate/ Sub-Divisional Magistrate/ Taluka Magistrate/ Executive Magistrate/ Extra Assistant Commissioner.
- (b) Chief Presidency Magistrate/Addl. Chief Presidency Magistrate/Presidency Magistrate.
- (c) Revenue Officer not below the rank of Tehsildar.
- (d) Sub-Divisional Officer of the area where the Applicant and/or his family normally resides.
- (e) Administrator/Secretary to the Administrator/Development Officer (Lakshadweep Islands).

The applicant must note that the SC/ST Certificate from any other person/ authority shall not be accepted in any case. If the applicant happens to belong to SC or ST, applicant's caste/ tribe must be listed in the appropriate Govt. of India Schedule. The Caste Certificate should clearly state: (a) Name of his/ her caste/ tribe (b) whether applicant belongs to SC or ST (c) District and the State or Union Territory of applicant's usual place of residence, and (d) the appropriate Govt. of India Schedule under which his/ her caste/ tribe is approved as SC or ST.

If the applicants do not have the SC or ST caste/tribe certificate at the time of registration/applying, the applicant may upload the acknowledgement slip of the SC or ST caste/tribe certificate application. However, at the time of admission, the applicant will have to produce the valid original SC or ST caste/tribe certificate.

However, if an SC/ST Applicant seeks admission under some other category (for example: PwD/Employee Ward, etc.) the applicant should satisfy the minimum eligibility requirement for that particular category.

Note: SC/ST applicants, who get admission under open merit (unreserved) shall not be included in the reserved quota, i.e. 22.5% (15% for SC and 7.5% for ST).

Reservation of Seats for Other Backward Classes (OBC)

- 27% seats will be reserved for the applicants belonging to OBC (non-creamy layer, central list).
- At the time of giving admission to an OBC applicant, the College will ensure that the caste is included in the Central List of OBC(the OBC status is to be determined on the basis of the Central List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes available at the website http://ncbc.nic.in/backward classes/index.html.
- The certificate must mention non-creamy layer status of the applicant (Noncreamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93-Estt. (SCT) dated 15.11.1993).
- The OBC applicants who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of 'creamy layer' status of the applicants as per DOPT Office Memorandum No. 36036/2/2013-Estt.(Res-I) dated 31 March 2016). The validity of the non-creamy layer certificate shall be for the financial year 2016-2017.
- If the applicants do not have the OBC non-creamy layer certificate of the financial year 2016-2017 at the time of upload, the applicant may upload old OBC noncreamy layer certificate/acknowledgement slip of OBC non-creamy layer certificate application. However, at the time of admission, the applicant will have to produce the OBC noncreamy layer certificate of the financial year 2016-2017.
- The OBC applicants shall be given a relaxation of 10% in the minimum eligibility marks of the said programme and in the admission entrance test 10% of the minimum eligibility marks prescribed for General Category applicants.
- It is a statutory obligation on the part of Colleges to fill all seats reserved for OBC applicants.

- The Colleges shall not refuse admission to any OBC applicant on the basis of medium of instruction. Any deficiency in the knowledge of any particular language should be removed, remedial classes for which may be arranged by utilizing grants that are available from University Grants Commission.
- If the seats meant for OBC remain vacant after arriving at the minimum eligibility, the same may be converted and filled up by other eligible applicants subject to approval from the University.

Note: The merit list for the unreserved category seats will comprise of all the applicants in the order of merit. No one will be excluded from the same. In other words, it will also include SC / ST / OBC applicants, if they come in unreserved merit. The applicant cannot be excluded from the unreserved category merit list just because he belongs to SC/ST/OBC. Such an applicant is entitled to be considered under the unreserved category, as well as under the reserved category. Admission to unreserved category seats will be strictly in the order of merit without excluding SC/ST/OBC applicants.

Reservation of Seats for Persons with Disabilities (PwD) (Supernumerary Seats)

As per the provisions of Rights of Persons with Disabilities Act, 2016, not less than five percent (5%) seats are reserved for Persons with Benchmark Disabilities, where "person with benchmark disability" means a person with not less than forty percent (40%) of a specified disability where specified disability has not been defined in measurable terms and includes a person with disability where specified disability has been defined in measurable terms, as certified by the certifying authority. It may be noted that the erstwhile Persons with Disability Act, 1995, under which reservation for Persons with Disabilities in admissions was provided earlier has now been repealed. The following specified categories of disabilities as mentioned in the Schedule to the Rights of Persons with Disabilities Act, 2016 [See clause (zc) of section 2 of Act of

 $Rights of Persons \ with \ Disabilities \ Act, 2016] \ are \ eligible \ to \ get \ the \ benefit \ of \ the \ said \ reservation;$

1. Physical disability:

- A. Locomotor disability (a person's inability to execute distinctive activities associated with movement of self and objects resulting from affliction of musculoskeletal or nervous system or both), including—
- a "leprosy cured person" means a person who has been cured of leprosy but is suffering from—
- i loss of sensation in hands or feet as well as loss of sensation and paresis in the eye and eye-lid but with no manifest deformity;
- ii manifest deformity and paresis but having sufficient mobility in their hands and feet to enable them to engage in normal economic activity;
- extreme physical deformity as well as advanced age which prevents him/her from undertaking any gainful occupation, and the expression "leprosy cured" shall construed accordingly;
- b "Cerebral palsy" means a Group of non-progressive neurological condition affecting body movements and muscle coordination, caused by damage to one or more specific areas of the brain, usually occurring before, during or shortly after birth;
- c "dwarfism" means a medical or genetic condition resulting in an adult height of 4 feet 10 inches (147 centimeters) or less;
- d "muscular dystrophy" means a group of hereditary genetic muscle disease that weakens the muscles that move the human body and persons with multiple dystrophy have incorrect and missing information in their genes, which prevents them from making the proteins they need for healthy muscles. It is characterised by progressive skeletal muscle weakness, defects in muscle proteins, and the death of muscle cells and tissue;
- e "acid attack victims" means a person disfigured due to violent assaults by throwing of acid or similar corrosive substance.
- B. Visual impairment-
- a "blindness" means a condition where a person has any of the following conditions, after best correction
- i total absence of sight; or
- ii visual acuity less than 3/60 or less than 10/200 (Snellen) in the better eye with best possible correction; or
- iii limitation of the field of vision subtending an angle of less than 10 degree.
- b "low-vision" means a condition where a person has any of the following conditions, namely:
- i visual acuity not exceeding 6/18 or less than 20/60 upto 3/60 or upto 10/200 (Snellen) in the better eye with best possible corrections; or
- $ii \qquad \qquad limitation of the field of vision subtending an angle of less than 40 degree up to 10 degree.$
- C Hearing impairment
- a "deaf" means persons having 70 DB hearing loss in speech frequencies in both ears;
- b "hard of hearing" means person having 60 DB to 70 DB hearing loss in speech frequencies in both ears;
- D "speech and language disability" means a permanent disability arising out of conditions such as laryngectomy or aphasia affecting one or more components of speech and language due to organic or neurological causes.
- 2. **Intellectual disability,** a condition characterised by significant limitation both in intellectual functioning (reasoning, learning, problem solving) and in adaptive behaviour which covers a range of every day, social and practical skills, including
- a "specific learning disabilities" means a heterogeneous group of conditions wherein there is a deficit in processing language, spoken or written, that may manifest itself as a difficulty to comprehend, speak, read, write, spell, or to do mathematical calculations and includes such conditions as perceptual disabilities, dyslexia, dysgraphia, dyscalculia, dyspraxia and developmental aphasia;
- b "autism spectrum disorder" means a neuro-developmental condition typically appearing in the first three years of life that significantly affects a person's ability to communicate, understand relationships and relate to others, and is frequently associated with unusual or stereotypical rituals or behaviours.

3. Mental behaviour

"mental illness" means a substantial disorder of thinking, mood, perception, orientation or memory that grossly impairs judgment, behaviour, capacity to recognise reality or ability to meet the ordinary demands of life, but does not include retardation which is a condition of arrested or incomplete development of mind of a person, specially characterised by subnormality of intelligence.

4. Disability caused due to

- a Chronic neurological conditions, such as
- i "Multiple Sclerosis" means an inflammatory, nervous system disease in which the myelin sheaths around the axons of nerve cells of the brain and spinal cord are damaged, leading to demyelination and affecting the ability of nerve cells in the brain and spinal cord to communicate with each other;
- ii "Parkinson's disease" means a progressive disease of the nervous system marked by tremor, muscular rigidity, and slow, imprecise movement, chiefly affecting middle-aged and elderly people associated with degeneration of the basal ganglia of the brain and a deficiency of the neurotransmitter dopamine.
- b Blood disorder
- i "Haemophilia" means an inheritable disease, usually affecting only male but transmitted by women to their male children, characterised by loss or impairment of the normal clotting ability of blood so that a minor would may result in fatal bleeding;
- $ii \quad "Thalassemia" \, means \, a \, group \, of \, inherited \, disorders \, characterised \, by \, reduced \, or \, absent \, amounts \, of \, haemoglobin.$
- iii "Sickle Cell Disease" means a hemolytic disorder characterised by chronic anemia, painful events, and various complications due to associated tissue and organ damage; "hemolytic" refers to the destruction of the cell membrane of red blood cells resulting in the release of hemoglobin.
- **5. Multiple Disabilities** (more than one of the above specified disabilities) including deaf blindness which means a condition in which a person may have combination of hearing and visual impairments causing severe communication, developmental, and educational problems.
- 6. Any other category as may be notified by the central government.

Reservation for CW Category

5% of the seats in each course have to be offered to the Children/Widows/Wives of Officers and Men of the Armed Forces including Para-Military Personnel, in the order of preference given below. Such candidates will be required to get their names registered at Room No. 218, II Floor, New Administrative Block, North Campus, University of Delhi.

- I. Widows/Wards of Defence personnel killed in action;
- ii. Wards of serving personnel and ex-servicemen disabled in action;
- iii. Widows/Wards of Defence personnel who died in peace time with death attributable to military service;
- iv. Wards of Defence personnel disabled in peace time with disability attributable to military service;
- v. Wards of Ex-servicemen personnel and serving personnel including police personnel who are in receipt of Gallantry Awards.

Relaxation to the extent of 5% in the minimum marks in the aggregate or in the subject, as the case may be, will be given to the candidates of the above mentioned categories while determining their eligibility to the course concerned. For purpose of registration, the candidates are required to submit their applications on a prescribed form available at the Registration Centre, along with two self-attested Photostat copies as well as the originals of the required certificates which will be returned to them after endorsement on the reverse of the original certificates. In order to become eligible for the above concessions, the Children/ Widows/Wives of the Officers and Jawans etc. will be required to submit the certificate of educational concessions (in original) from anyone of the following authorities:

- Secretary, Kendriya Sainik Board, Delhi Secretary, Rajya/Zila Sainik Board
- Officer-in-Charge, Record Office
 First-Class Stipendiary Magistrate
- Ministry of Home Affairs (For police personnel in reciept of Gallantry Awards)

Note: For additional concessions, students are advised to contact the college Principal.

Reservation of Seats for Foreign Students

All foreign candidates seeking admission and satisfying the course and age requirements must apply through the Foreign Students' Advisor, University of Delhi, Delhi-110007. Admission of these candidates will only be confirmed on presentation of a valid medical certificate, as required by the University of Delhi within a month of their admission. All foreign students, including those who have completed their schooling from an Indian Board may be treated as Foreign Students for the purpose of their registration/ admission in various departments and Colleges of the University and they may be considered for admission under 5% quota prescribed for foreign students. The Colleges/ Departments are advised to keep a column of nationality in their admission form.

SPORTS QUOTA

It is mandatory for all Colleges to provide sports facilities and encourage all students to participate in sports and extracurricular activities by introducing inter-class competitions and mass sports.

Upto 5% seats have been reserved for students with proficiency in Sports. Students under this category must fill the sports application and attach copies of the relevant certificates duly attested by the Principal of the Institution last attended.

The college has requirement of players in the following games:

1. Football 2. Hockey 3. Volleyball 4. Handball 5. Kho-Kho 6. Baseball 7. Athletics 8. Cross Country 9. Netball 10. Taekwondo 11. Shooting 12. Archery 13. Badminton 14. Table-Tennis 15. Yoga 16. Ball Badminton 17. Basket Ball 18. Swimming 19. Boxing.

If a suitable candidate is not found for any particular sports, then that seat shall be transferred to another sport as required.

ECA QUOTA

Students seeking admission under ECA category must fill up the centralised online form and attend trials for their category at the college specified by the Cultural Council of Delhi University.

Procedure for Admission of Kashmiri Migrants:

The wards of the Kashmiri Migrants will be registered centrally by the University for admission to various undergraduate courses under the Faculties of Arts, Social Science, Commerce and Business, Mathematical Sciences and Faculty of Science, except to the courses where admissions are made on the basis of entrance test and the allotment of seats to the courses/colleges will be made on the basis of merit. There is 5% course-wise supernumerary quota for Kashmiri Migrants. All Kashmiri migrants who have been issued certificates across the country will be considered for admission.

Candidates seeking admission under the ward quota must also apply online. The candidate will enter details of guardian ie. name, designation and place of work [employer) in the online form. The colleges follow the AC resolution 206 dated 27.07.1996.

Nomination of seats for Sikkimese Students (Supernumerary Seats)

Sikkimese students nominated by the Govt. of Sikkim shall be considered for admission by the University in Colleges where hostel facilities are available (AC Resolutions 51 dated 05/06/1980 and 122 dated 17/12/1990). The applicants who wish to be considered under this category shall also apply online on the UG admission portal. The allocation of Sikkimese students for admission as well as for hostel accommodation in respective colleges be made by the Vice-Chancellor at his discretion.

Candidates whose results are not declared within the prescribed dates and who are unable to comply
with the requirements of the University (such as provisional certificates, detailed mark sheets etc) will
not be considered eligible even for provisional admission.

Compartmental Candidates

- Candidates with Compartment in one subject at the Senior School Certificate Examination of the Central Board of
 Secondary Education/Statutory University Board will be eligible for provisional admission, if they satisfy the
 course requirements by adding the minimum pass marks of the subject in which the candidate has been placed
 under compartment, to the marks obtained in the remaining best three subjects. Candidates, who fail to appear in or
 do not pass the Compartmental examination by December of the year of admission, shall not be entitled to continue
 on the rolls and their provisional admission will be cancelled.
- No Student shall be denied admission due to gap year(s).

No Student can pursue two degree courses simultaneously at the same University / different University or recognised Institution. In cases where the University permits such a study, prior approval of the Principal is necessary. It is to be noted that admission will be automatically cancelled, if the student is found pursuing a second course of study illegally.

DOCUMENTS REQUIRED AT THE TIME OF ADMISSION

The applicants shall be required to produce following documents in original with two sets of self-attested photocopies at the time of admission:

- 2. Class X Marks-Sheet

- 5. Character Certificate (recent)
- 6. SC/ST/PWD/CW/KM Certificate (in the name of the candidate) issued by the competent authority
- 7. OBC (Non- Creamy Layer) Certificate (in the name of the Candidate)) issued by the competent authority
- 8. Transfer Certificate from school/ college as well as Migration Certificate from Board/ University are required from those students who have passed senior secondary exam from outside Delhi
- 9. At least two passport size self-attested photographs.

The University will accept self-attested copies of documents/papers provided by the students. It is made clear that if any false attestation/falsified records are detected, the student will be debarred from attending any course in the University/ or its Colleges for next five years and in addition, a criminal case under relevant sections of IPC (viz. 470,471,474 etc.) will be instituted against him/her.

- 2. Admission to post-graduate courses will be regulated through central registration by the University as in previous years. The College will admit only those having provisional admission slips issued by the respective faculties.

CHOICE BASED CREDIT SYSTEM (CBCS)

The CBCS provides an opportunity for the students to choose courses from the prescribed courses comprising core, elective/minor or skill based courses. The courses can be evaluated following the grading system, which is considered to be better than the conventional marks system. Therefore, it is necessary to introduce a uniform grading system in the entire higher education in India. This will benefit the students to move across institutions within India to begin with and across countries. The uniform grading system will also enable potential employers in assessing the performance of the candidates. In order to bring uniformity in evaluation system and computation of the Cumulative Grade Point Average (CGPA) based on student's performance in examinations, the UGC has formulated the guidelines to be followed.

Outline of Choice Based Credit System:

- 1. Core Course: A course, which should compulsorily be studied by a candidate as a core requirement is termed as a Core course.
- 2. Elective Course: Generally a course which can be chosen from a pool of courses and which may be very specific or specialized or advanced or supportive to the discipline/ subject of study or which provides an extended scope or which enables an exposure to some other discipline/ subject/domain or nurtures the candidate's proficiency/skill is called an Elective Course.
 - 2.1 Discipline Specific Elective (DSE) Course: Elective courses may be offered by the main discipline/ subject of study is referred to as Discipline Specific Elective. The University/ Institute may also offer discipline related Elective courses of interdisciplinary nature (to be offered by main discipline/subject of study).
 - 2.2 Dissertation/Project: An elective course designed to acquire special/ advanced knowledge, such as supplement study/support study to a project work, and a candidate studies such a course on his own with an advisory support by a teacher/faculty member is called dissertation/project.
 - 2.3 Generic Elective (GE) Course: An elective course chosen generally from an unrelated discipline/ subject, with an intention to seek exposure is called a Generic Elective.
 - P.S.: A core course offered in a discipline/subject may be treated as an elective by other discipline/ subject and vice versa and such electives may also be referred to as Generic Elective.
- 3. Ability Enhancement Courses (AEC)/Competency Improvement Courses/Skill Development Courses/Foundation Course: The Ability Enhancement (AE) Courses may be of two kinds: AE Compulsory Course (AECC) and AE Elective Course (AEEC). "AECC" courses are the courses based upon the content that leads to Knowledge enhancement. They ((i) Environmental Science, (ii) English/MIL Communication) are mandatory for all disciplines. AEEC courses are value-based and/or skill-based and are aimed at providing hands-on-training, competencies, skills, etc.
 - 3.1 AE Compulsory Course (AECC): Environmental Science, English Communication/ MIL Communication.
 - 3.2 AE Elective Course (AEEC)/SEC: These courses may be chosen from a pool of courses designed to provide value-based and/or skill-based instruction.
 - Project work/Dissertation is considered as a special course involving application of knowledge in solving / analyzing /exploring a real life situation / difficult problem. A Project/Dissertation work would be of 6 credits. A Project/Dissertation work may be given in lieu of a discipline specific elective paper.

There are 3 streams in each language and the option for each student is contingent upon whether the student has passed a language test at Class XII, Class X or Class VIII level. Stream A implies that the student has successfully passed English/Hindi at the level of class XII. Stream B means that the student has passed English/ Hindi at the level of class X. Stream C means that the student has passed English and Hindi examination at the level of Class VIII.

Those students, who have not studied Hindi at any of these levels, are offered Philosophy in lieu of Hindi. Students who have not studied Hindi upto class VIII are expected to take the compulsory Hindi exam within three years of joining college.

Note: Students who have not offered Vocal Music as a subject in class Xth or XIIth or have not passed any Music Examination from any other school but wish to take Music as a subject may have to appear for a Music Test.



Admission Procedures

The students admitted on the basis of sports will be compulsorily required to participate in sports practice/matches/competitive events and other such related activities throughout the duration of their stay in the college. Refusal/failure to do so will invite disciplinary action, which may also involve cancellation of admission. Candidates will be required to sign a bond to this effect.

NOTIFICATIONS

NOTIFICATIONS

- 1. After declaration of the cut off lists by the University, the student will need to report to the college of her choice for admission within the stipulated period. The student would then get her documents verified and pay the admission fee.
- 2. In case, a student cancels her admission in a college, in order to move to another college on declaration of a subsequent cut off list or needs certificates for institutions outside Delhi University, the college must promptly return the documents to the student.
- 3. No student will be allowed to take admission in two courses/colleges simultaneously. In case, they are found to be admitted in two courses/colleges simultaneously, their admission will be cancelled.

Concession/Waiver of fees in respect of Persons With Physical Disabilities (PwD)

- 1. Consequent upon amendment to Ordinance X(4) of the University, the following proviso has been added after Sub-clause 2 of Ordinance X(4) of the said Ordinance:
 - "Provided that the Persons With Physical Disabilities shall be waived off all the fees payable including the Examination fee and other University fees, except Admission fee, subscription towards Delhi University Students' Union and Identity Card fee for pursuing under-graduate, post-graduate or other courses in the University or its Colleges."
- 2. In pursuance of the above, the students with physical disabilities pursuing various courses of study in the Faculties, Departments, Centers, and Institutions/Colleges of the University shall be exempted from payment of fees, including examination fee and other University fees, except Admission fee, subscription towards Delhi University students' Union and Identity Card fee.
- 3. In pursuance of the Executive Council Resolution No. 50 dated 03.11.2012, it is notified that the students with physical disabilities residing in different Hostels/Halls of the University are exempted from payment of all hostel fees and charges except refundable caution fee and the mess fees. The Persons with Physical Disabilities students shall pay 50% of the Mess fee and the remaining 50% of the Mess Fee in respect of the PwD students is being met by the University. Similar norms are to be adopted by the Colleges in respect of PwD Students residing in various hostels of the Colleges.
 - It is clarified further that the PwD students who are getting fellowships/financial assistance shall be exempted from payment of fees/charges/mess fees subject to the following conditions:

Value of Fellowship	Exemption of Fees Waiver etc.	
Up to Rs. 3000/- per month	Fees waiver+50% Mess Subsidy	
Rs.3001 to 8000 per month	Fees waiver but no Mess Subsidy	
Rs. 8001 and above per month	No fees waiver and no Hostel Subsidy

ATTENDANCE RULES AND CREDITS

Ideally a student should attend all lectures, preceptorials, tutorials and practical classes held during the Semester in all the subjects (or papers). In case the student is unable to do so, then she/he must have:

- A minimum of 66.67% attendance in lectures, preceptorials, tutorials and practical classes separately in all the subjects (or papers) for all the six semesters of the course. Failing this, she/he will not be permitted to appear in the university examination.
- Please note that 66.66% attendance is also required in each course separately in each Semester, failing which the student will be detained.

Students who have missed classes on account of:

- I. A serious disabling illness
- II. Participation in Sports activities
- III. Participation in an Inter-College, inter-University event

should submit a medical/participation certificate duly signed by Teacher-in-charge at the college administrative office within 10 days of returning to college after recuperation/return.

Attendance of detained candidates will be calculated afresh for the Semester she has rejoined. Attendance for the Semester already passed will, however, remain unchanged.

Students failing to attend a minimum of 66.67% of the lectures/ tutorials / preceptorials / practical classes will not be permitted to appear in the University Examination.

5% weightage awarded for regularity in attending lectures and tutorials shall be calculated as follows:

85% and above	5 marks
80% or more but less than 85%	4 marks
75% or more but less than 80%	3 marks
70% or more but less than 75%	2 marks
67% or more but less than 70%	1 mark
Less than 67%	0 marks

Every student admitted to the College shall be compulsorily required to sign an undertaking that she shall fulfill the minimum attendance requirement.

The Monthly attendance of Students shall be uploaded on college Website.

Parents/guardians are requested to keep track of their ward's attendance in classes. They may note that if their ward falls short of the minimum attendance requirements, she shall not be permitted to appear in the Examination.

Smoking and consumption of alcohol is strictly prohibited in the campus. The college is a smoke free zone and the Nodal Officer for anti-smoking campaign is Ms. Vandana Madan, Convernor, Avani.



Examinations And Internal Assessment

UNIVERSITY EXAMINATIONS

University examinations are held at the end of each Semester in November and May, Promotion to the next class depends on passing the University examinations.

INTERNAL ASSESSMENT (Ord. VIII-E- Internal Assessment)

ORDINANCE VIII-E: Internal Assessment

- $The scheme for Internal Assessment shall be followed in the regular stream only. \ The specific Ordinances pertaining to schemes of examinations$ of various courses shall stand amended, mutatis mutandis, to the extent of internal assessment as laid down in this Ordinance.
- Internal Assessment marks shall be shown separately in the Marks Sheet issued by the University and these marks shall be added to the annual/semester examination marks for determining the division of the student. 2 25% of the maximum marks in each paper in undergraduate courses shall be assigned for Internal Assessment and the remaining 75% marks for the annual/semester University Examination; the time duration and other modalities of the annual/semester Examination with respect to this 75% component shall remain as per existing schemes of examination for various undergraduate courses.
- 2.1.1. For the Annual Examination Scheme, there shall be 10% weightage assigned to House Examinations to be conducted by each college, for all subjects in B.A., B.Com, and B.Sc, courses and all papers of the Main Subject in Honours courses. For the Semester Examination Scheme, there shall be 10% weightage assigned to Class Test(s)/Quiz(s) to be conducted by each college, for all subject in B.A., B.Com. and B.Sc. courses and all papers of the Main Subject in Honours courses.
- 2.2.1. Each student shall be assessed on the basis of written assignments/tutorials as well as on the basis of project reports/term papers/seminars. There shall be 10% weightage for such written assignment; and project reports/presentations/term papers/seminars. Each student shall be given at least one written assignment per paper in each term/semester.
- 2.2.2. There shall be 5% weightage for regularity in attending lectures and tutorials, and the credit for regularity in each paper, based on attendance, shall be as follows:

More than 67% but less than 70%-1 mark,

70% or more but less than 75%-2 marks

75% or more but less than 80% - 3 marks,

80% or more but less than 85%-4 marks

- 85% and above 5 marks [Medical certificates shall be excluded while calculating credit towards marks to be awarded for regularity, though such certificates shall continue to be taken into account for the purpose of calculating eligibility to appear for examinations as per the existing provisions of Ordinance VII.2.9.(a)(ii).]
- The promotion crieteria shall be as per the existing Ordinances for University Examinations, as applicable to respective courses. In addition, the same criteria shall apply to the total of the University Examination and the Internal Assessment, taken together.

Pass Percentage & Promotion Criteria

- 4.1.1 The minimum marks required to pass any paper in a semester shall be 40% in theory and 40% in Practical, wherever applicable. The student must secure 40% in the End Semester Examination and 40% in the Total of End Semester Examination & Internal Assessment of the paper for both
- A student shall be eligigle for promotion from 1st year to 2nd year of the course provided she/he has passed 50% papers of I and II semester taken together.
- Similarly, a student (irrespective of Part I results) shall be eligible for promotion from 2nd year to 3rd year of the course provided she/he has passed 50% paper of Ill and IV semesters taken together.
- 4.1.4 Students who dee not fulfill the promotion criteria (b) & (c) above shall be declared fail in the Part concerned. However, they shall have the option to retain the marks in the papers in which they have secured Pass marks as per Clause (a) above.

 A student who has to reappear in a paper prescribed for Semester I/III/V may do so only in the semester examinations to be held in
- November/December. A student who has to reappear in a paper prescribed for Semester II/IV/VI may do so only in the examination to be held in April/May.
- Reappearance in passed papers:
- 4.2.1 A student may reapper in any theory paper prescribed for a semester, on foregoing in writing her/his previous performance in the paper/s concerned. This can be done in the immediate subsequent semester examination only (for example, a student reappearing in a paper prescribed for Semester I examination, may do so along with subsequent Semester III examination and not along with papers for Semester V).
- 4.2.2 A candidate who has cleared the papers of Part III (V & VI Semester) may reappear in any paper of V or VI Semester only once, at the immediate subsequent examination on foregoing in writing her/ his previous performance the paper/s concerned, within the prescribed span period. (Note: The candidate of this category will not be allowed to join any postgraduate courses).

 4.2.3 In the case of reappearance in a paper, the result will be prepared on the basis of candidate's current performance in the
- examination.
- 4.2.4 In the case of a candidate, who opts to re-appear in any paper/s under the aforesaid provisions, on surrendering her/his earlier performance but fails to reapper in the paper/s concerned, the marks previously secured by the candidate in the paper/s in which she/he has failed to re-appear shall be taken into account while determining her/his result of the examination held currently.
- 4.2.5 Reappearance in Practical examinations shall not be allowed.
- Astuden who reappears in a paper shall carry forwared the internal assessment marks, originally awarded.
- Division Criteria:
 - Astudent who passes all the papers prescribed for Semester I to Semester VI examinations whould be eligible for the degree, Such a student shall be categorized on the basis of the combined result of Semester I to Semester VI examinations as follows:-
- 60% or more First Division 50% or more but less than 60% Second Division 40% or more but less than 50% Third Division In the case of a student who is selected as a member of the N.C.C. to participate in the annual N.C.C. Camps or is deputed to undertake Civil Defence work and allied duties, or in the case of a student who is enrolled in the National Service Scheme and is deputed to various public assignments by or with the approval of the Head of the institution concerned, or a student who is selected to participate in sports or other activities organized by the Inter-University Board or in national or international fixtures in games and sports approved by the Vice- Chancellor, or a student who is required to represent the University at the Inter-University Youth Festival, or a student who is required to participate in periodical training in the Territorial Army, or a student who is deputed by the College to take part in Inter-College sports, fixtures, debates, seminars, symposia or social work projects, or a student who is required to represent the College concerned in debates and other extracurricular activities held in other Universities or such other activities approved by the Vice-Chancellor, the following provision will apply
- A student in the categories listed above, will have to fulfil the requirement of written assignments and projects/termpapers/seminars/field-work with the flexibility, however, that he/she may, if necessary, be allowed additional time for submission of written assignments.
- A student in the categories listed above, who is unable to write the House Examination / Class Test(s)/Quiz(s) on account of his/her participation in such aforesaid activities, may be assessed by the College through an alternative mode. This may be done only in exceptional circumstances.
- A student in the categories listed above, will get the benefit of attendance for Internal Assessment for the classes missed as per the existing provisions of Ordinance VII.2.(9)(a)(i). 6 The University reserves the right to review, and if necessary moderate the marks in Internal Assessment in any paper/papers in any College/Department.



Code of Conduct

Students should avoid the following:

- Causing Disturbance in or outside rooms, the office, the library and the playgrounds.
- Refusal to participate in co-curricular or extra-curricular activities of the college or perform duties assigned to them.
- Misconduct or misbehavior of any kind especially during elections or students' meetings.
- Damage to the college building, property and books is strictly prohibited.
- Loitering outside the college gates is not allowed.
- Using or charging mobile phones in classrooms and corridors is strictly prohibited.

Students should comply with the following:

- Attendance in daily morning assemblies and long assemblies on Wednesdays is compulsory.
- Membership of the college library is compulsory.
- Parents/Guardians are requested to cooperate with the college authorities in maintaining discipline and decorum in the college.
- Students are expected to be respectful to the faculty and staff of the college.
- Students should regularly see college notice boards and website for important information.

Ordinance XV-B. Maintenance of Discipline among Students of the University

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he/she deems proper to the Proctor and to such other persons as he/she may specify in this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance, the following shall amount to acts of gross indiscipline:
 - (a) Physical assault, or threat to use physical force, against any member of the teaching and non-teaching staff of any Institution/Department and against any student within the University of Delhi;
 - (b) Carrying of, use of, or threat to use of any weapons;
 - (c) Any violation of the provisions of the Civil Rights Protection Act, 1976;
 - (d) Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes.
 - (e) Any practice-whether verbal or otherwise-derogatory of women;
 - (f) Any attempt at bribing or corruption in any manner;
 - $(g) \ Will ful \ destruction \ of institutional \ property;$
 - (h) Creating ill-will or intolerance on religious or communal grounds;
 - (i) Causing disruption in any manner of the academic functioning of the University system;
 - (J) Ragging as per Ordinance XV-C.

JDMC students are required to conduct themselves in a disciplined manner in the college premises and outside.

The Principal appoints a board of faculty members to take care of discipline among students with power to deal with breach of discipline.



- 4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any students of the University:
 - (a) be expelled; or
 - (b) be, for a stated period rusticated; or
 - (c) be not for a stated period, admitted to a course of courses of study in a College, Department or Institution of the University; or check
 - (d) be fined with a sum of rupees that may be specified; or
 - (e) be debarred from taking a University or College or Department Examination for one or more years; or
 - (f) that the result of the student or students concerned in the Examination or Examination in which he/she or they have appeared be cancelled.
- 5. The Principals of the Colleges shall have the authority to exercise all such disciplinary powers over students in their respective Colleges. They may exercise their authority through, or delegate authority to, such of the teachers in their Colleges, Institutions or Department as they may specify for these purposes.
- 6. The rules framed by the University may be supplemented, where necessary, by the Principal of the college. Each student is expected to provide herself with a copy of these rules. At the time of admission every student shall sign a declaration that on admission she shall submit herself to the disciplinary jurisdiction of the Vice Chancellor and the several authorities vested with the authority to exercise discipline under the Acts, Statutes and Ordinances framed by the University.

$Or dinance\,XV-C.\,Prohibition\,of\,and\,Punishment\,for\,Ragging$

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of Delhi University system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this Ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in way considered junior or inferior by other students and includes individual or collective acts or practices which
 - a) Involve physical assault or threat to use of physical force;
 - (b) Violate the status, dignity and honour of women students;
 - $(c) \ Violate \ the \ status, dignity \ and \ honour \ of \ students \ belonging \ to \ the \ scheduled \ castes \ and \ tribes;$
 - (d) Expose students to ridicule and contempt and affect their self esteem;
 - (e) Entail verbal abuse and aggression, indecent gestures and obscene behaviour.
- 4. The Principal of a College shall take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in Clause (4) above, the Proctor may also suo motto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.
- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under Clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), and (c) the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.



- 10. The Vice-Chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a course of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be cancelled.
- 11. In case any students who have obtained degrees of Delhi University are found guilty under this Ordinance appropriate action under Statute 15 for withdrawal of degrees conferred by the University shall be initiated.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way or any act, practice or incitement of ragging will also amount to ragging.
- 13. All institutions within the Delhi University system shall be obligated to carry out instruction/directions issued under this Ordinance, and to give aid and assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

NOTE: ORDER OF THE VICE-CHANCELLOR in pursuance of Ordinance XV-C

Where incident(s) of ragging are reported to the Vice-Chancellor by any authority, the student(s) involved in ragging shall be expelled for a specified term, designated Non-students involved in reports of ragging will be proceeded with under the criminal law of India; they will also be rendered ineligible for a period of five years from seeking enrolment in any of the institutions of the University of Delhi. Students against whom necessary action is taken under this note, will be given post decisional hearing, with strict adherence to the rules of natural justice. in the order.

XV-D-Sexual Harassment

Some significant aspects of Delhi University's Ordinance XV-D: Sexual Harassment are as follows (For details, please check the college website: www.jdm.du.ac.in):

1. Short Title and Extent:

The present ordinance is based on the Policy against Sexual Harassment by the Delhi University and seeks to maintain and create an academic and work environment free of sexual harassment for students, academic and non-teaching staff of the Delhi University. The ordinance will also apply to outsiders and residents, on the Delhi University campus, to the extent specified herein these rules and procedures. "Sexual harassment" includes any unwelcome sexually determined behaviour, whether directly or by implication and includes physical contact and advances, a demand or request for sexual favours, sexually-coloured remarks, showing pornography or any other unwelcome physical, verbal or non-verbal conduct of sexual nature.

2. Explanation. "Sexual harassment" shall include, but will not be confined to the following:

- (a) When submission to unwelcome sexual advances, requests for sexual favours, and verbal or physical conduct of a sexual nature are made, either implicitly or explicitly, a ground for any decision relating to employment, performance, extra-curricular activities, or entitlement to services or opportunities at the Delhi University.
- (b) When unwelcome sexual advances, and verbal, non-verbal and/or physical conduct such as loaded comments, remarks or jokes, letters, phone calls or e-mail, gestures, exhibition of pornography, lurid stares, physical contact, stalking, sounds or display of a derogatory nature have the purpose and/or effect of interfering with an individual's performance or of creating an intimidating, hostile, or offensive environment.
- (c) When a person uses, with a sexual purpose, the body or any part of it or any object as an extension of the body in relation to another person without the latter's consent or against the person's will, such conduct will amount to sexual assault.
- (d) When deprecatory comments, conduct or any such behaviour is based on the gender identity /sexual orientation of the person and/or when the classroom or other public forum of the University is used to denigrate/discriminate against a person or create a hostile environment on the basis of a person's gender identity/sexual orientation.

3. Scope of the Ordinance:

This Ordinance shall be applicable to all complaints of sexual harassment made:

(I) by a member of the University against any other member of the University irrespective of whether the harassment is alleged to have taken place within or outside the campus.



- (ii) by a resident against a member of the University or by a member against a resident irrespective of whether the sexual harassment is alleged to have taken place within or outside the campus.
- (iii) by an outsider against a member of the University or by a member of the University against an outsider if the sexual harassment is alleged to have taken place within the campus.
- (iv) by a member of the university, against an outsider if the sexual harassment is alleged to have taken place outside the campus. In such cases the Committee shall recommend that the University college authorities initiate action by making a complaint with the appropriate authority. Further the committee will actively assist and provide available resources to the complainant in pursuing the complaint.

4. Complaint Mechanism:

(i) College Complaints Committees, which shall be set up in each college of the University of Delhi as complaints and redressal bodies.

5. Redressal:

- (i) CCC may ask the College to suspend the alleged harasser from an administrative post/class if his/her presence is likely to interfere with the enquiry.
- (ii) The victim of sexual harassment shall have the option to seek transfer of the perpetrator or her/his own transfer where applicable.
- (iii) Notwithstanding the contents of any other ordinance relating to service conditions etc., the head of the institution upon receipt of the enquiry report, shall refer the same to the Governing Body/Executive Council (EC) and take disciplinary action on the basis of recommendations of the Complaint Committees provided that in the case of termination of service the existing rules of the University will also be forwarded.
- (iv) The disciplinary action shall be commensurate with the nature of the violation.

A. In the case of University/College employees; disciplinary action may be in the form of:

(I) Warning

(vii) Denial of re-employment

(ii) Written apology

(viii) Stopping of increments/promotion

(iii) Bond of good behavior

(ix) Reverting, demotion

(iv) Adverse remarks in the Confident Report

(x) Suspension

(v) Debarring from supervisory duties

(xi) Dismissal

(vi) Denial of membership of statutory bodies

(xii) Any other relevant mechanism

B. In case of students, disciplinary action may be in the form of:

(i) Warning

(viii) Debarring from contesting elections

(ii) Written apology

(ix) Debarring from holding posts

(ii) Bond of good behavior

(x) Expulsion

(iv) Debarring entry into a hostel/campus

(xi) Denial of admission

(iii) Suspension for a specified period of time

(xii) Declaring the harasser as "persona non grata" for a stipulated period of time.

(vi) Withholding results

(xii) Any other relevant mechanism.

(Vii) Debarring from exams

C. In the case of third party harassment, the University/College authorities shall initiate action by making a complaint with the appropriate authority.



RIGHT TO INFORMATION

According to Government of India, Right to Information (RTI) is

- (i) An Act to provide for setting out the practical regime of right to information for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority, the constitution of a Central Information Commission and State Information Commissions and for matters connected therewith or incidental thereto.
- (ii) WHEREAS the Constitution of India has established democratic Republic;
- (iii) AND WHEREAS democracy requires an informed citizenry and transparency of information which are vital to its functioning and also to contain corruption and to hold Governments and their instrumentalities accountable to the governed;
- (iv) AND WHEREAS revelation of information in actual practice is likely to conflict with other public interests including efficient operations of the Governments, optimum use of limited fiscal resources and the preservation of confidentiality of sensitive information;
- (v) AND WHEREAS it is necessary to harmonise these conflicting interests while preserving the paramountcy of the democratic ideal;
- (vi) According to the university, the first apellate authority of the college is the Principal, who is responsible for all matters pertaining to RTI in this institution.
- (vii) BE it enacted by Parliament in the Fifty-sixth Year of the Republic of India.

 - 7. संस्था की संपत्ति का जानबूझकर नाश।
 - 8. धार्मिक या सांप्रदायिक आधार पर किसी भी तरह का व्यवधान उत्पन्न करना।
 - 9. विश्वविद्यालय व्यवस्था के शैक्षिणक कार्यों में किसी भी तरह का व्यावधान उत्पन्न करना।
 - 10. अध्यादेश **15C** के तहत रैगिंग

 - च. परीक्षा में छात्रा का परीक्षाफल या परीक्षा से संबंधित छात्रा या परीक्षा जिसमें वह उपस्थित हो चुकी हैं, को रद्द किया जा सकता है।

SEMINARS/ WORKSHOPS/ TALKS ORGANISED IN 2018-19

Department of Commerce organized Comtalk 2018 as part of their Annual Inter-College Commerce Festival on 23rd February 2018. The event witnessed diverse discussions and workshops on its theme of "Cyber World, Digital Footprint and Cyber Security Ecosystem". The event garnered participants from various colleges of Delhi University. In collaboration with the English department, the department also organized a lecture on "Strategies in Emerging Market" by Professor Annette Ammeraal from University of Applied Sciences Utrecht. During the academic year the department organized an orientation programme in collaboration with ICICI securities to encourage students to participate in Stockmind 2017, a national level competition.

Department of Economics annual Inter-college festival, Ecophoria, was held on 27th September 2017. The festival was inaugurated by Professor Sunil Kanwar from Delhi School of Economics, followed by a series of events. One of the main highlights of the event was Econferentia where various papers were presented on topics such as 'Intellectual Property Rights and Developing Countries', 'How Sustainable is India's Growth', 'Direct Benefit Transfer – An Apt Policy for India', 'Interest Rate Cut -A Good Policy?' and 'Trade-Still an Engine of Growth'. In addition to its magazine Ecogene, this year, the department launched its interactive online blog 'Ecognizance: Economics in Panorama', to increase its interaction with students and provide information on changing perspectives in political economy and world affairs.

Department of English has an ongoing project, Memoirs, under which various papers by faculty members such as, Rita Sinha's "Political Movements in India: From 1920's to 1977" and Payal Nagpal's "Text as Performance" were presented. The department held its Writer's Workshop inviting eminent personalities like film maker Anusha Rizvi, writer Saikat Majumdar, novelist Sudeep Chakravarti, graphic novelist Vishwajyoti Ghosh, poet Akhil Katyal, and publisher Shantanu Ray Chaudhari. The session was moderated by Yoda press founder and editor Ms. Arpita Das. The topics of the workshop ranged from the role of memory in creative expression to the resistance of state censorship. The workshop was followed by a two-day literary festival called Tabir 2018, which was a conglomeration of competitive and fun events, addressing issues and creating awareness about various social issues prominent in our contemporary times.

Department of Environmental Studies organized a series of field visits to Aravalli Bio-Diversity Park and Yamuna Bio-Diversity Park in Feb-March 2018 as part of the curriculum. During August to November 2017, the students worked with the college garden committee to clean and maintain the college gardens under the guidance of Dr Nisha Malik. Students also helped to develop the Ecozone in the campus with the help of "Give Me Trees," a charitable trust which collaborated with AVANI. Students learnt to make bio-enzyme and were also involved in activities like seed collection, sapling plantation and nest making from waste.

Department of Hindi under the aegis of their Literary Association Parag, organized a seminar from 14th to 16th September 2017. With its inaugural by Mr. Pooranchand Tandon, the department celebrated Hindi week during the seminar. On the last day of its Hindi Week, the department organized a Youth Poet Summit, Navsvar, where prominent personalities such as Kumari Manisha Shukla, Sachin Aggarwal, Nikunj Sharma and Shobha Sachan encouraged the young poets. The stage of Navsarwas coordinated by acclaimed poet Mr. Chirag Jain. From 8th-9th March 2018, the Hindi department also organized a seminar on the topic "Hindi Cinema aur Lok Natya: Bhavaur Abhinaya" where numerous luminaries of Hindi literature including Dr. Sharad Alok, Mr. Deepak Parvatiyar and Dr. Amitesh Kumar presented their ideas and shared their creative expressions with faculty and students.

The department, collectively with faculty and students, successfully initiated a fund-raising drive to facilitate the procurement of an 'Orbital Prosthesis' for a twenty-year-old Retinoblastoma survivor, Shyam Dubey a student of DU. Throughout the academic year the HDFE department delivered special lectures on pressing topics such as, "Hearing Impairment in Children", "Visual Disability in Children", "Gender and Patriarchy" and "Children in Difficult Circumstances". It helped the students to think outside the course work and deal with real life societal concerns.

A Career Counselling Session was held in January 2018 and paper presentations on "Mathematics and Architecture" were organized on March 14, 2018.

Department of Music and *Sarang* Music Society jointly organized a Santoor Recital titled, "*Melodies of the Mountains*" by Mr. Kaviraj Singh (U.K.) and Mr. Zoheib Khan (Delhi) on 21st February, 2018. The department also organized singing auditions for YouTube (web series) by the NGO *SATRANG RAGINI* – Hindustani Classical Solo Vocal Music Competition was also held as an annual event at *Symphony*, on 11th January, 2018 in which 12 colleges across Delhi University participated. An educational trip to The *All India Radio, Sangeet Natak Akademi and Shri Ram Bharatiya Kala Kendra* was also organized for the students.

Department of Philosophy organized the annual 'Nandita Rajguru Memorial Debate'on 10th January 2018, which discussed the philosophical question, "All war is a Symptom of Man's Failure as a Thinking Animal". The debate garnered 27 teams from diverse backgrounds who actively and enthusiastically participated in the event. For its departmental festival, Revelation, the faculty focused on the theme "Indian Cinema: Emerging Trends and Philosophical Interpretations". During the festival eminent Fulbright Nehru Academic and Professional Excellence Fellow from Oberlin College, Prof. Anuradha Needham delivered a special lecture on "Representation of Women in Popular Indian Cinema of the 1950s and 60s".

Department of Physical Education organised a week long Sports Day, which culminated on 27th February 2018. World Cadet Wrestling Championship participant and Commonwealth Double Silver Medalist, Ms. Kamini Yadav was the Chief Guest for the occasion and Mr. Bajrang Lal, the senior Football Coach in Sports Authority of India was Guest of Honour. The Department organized Inter College Yoga Championship 2017-18 on 15th-17th February, 2018 at MPH, Rugby grounds, University of Delhi. *7A Side* Football Tournament was conducted on 21st February, 2018 to promote Football among Women in Delhi. The department played host to Inter-College Hockey, Delhi Senior and Junior State Hockey Tournaments in November 2017. The Delhi State Training-cum-Selection Camp for Sub-Junior National and School Nationals in Football were also conducted at JDMC grounds during November-December 2017. The department conducted Admission trials for Undergraduate Admissions on Sports Quota in the games of Football and Hockey during June -July 2017 as well as Women's Hockey 6A Side Tournament for two days on 22nd and 23rd June, 2017 to celebrate Delhi Olympic Day.

Department of Political Science celebrated its departmental festival, Politique, on 18th and 19th January 2018. The theme of the festival was "Uniform Civil Code and the Personal Laws of Minorities". The festival was inaugurated by renowned political science scholar and a professor of Jawahar Lal Nehru University, Prof. Gurpreet Mahajan. Many competitions were organized under the rubric of Politique, namely, Argumentative India, a debate competition, Chanakya, Quiz Competition, Pari kalpana, the logo making competition and so on. All the competitions received tremendous response from numerous colleges of Delhi University. During the academic year, the department organized a special lecture entitled 'Democracy, Development and Good Governance: Convergence in India', by a prolific political science scholar, Dr. Rimki Basu, from Jamia Milia Islamia University.

Department of Sanskrit's association organized a lecture on "Sanskrit & World literature" by Dr. Ashutosh Dayal Mathur on 25th January, 2018. During the annual cultural festival *Symphony 2018*, Sanskrit association organized a *Sanskrit Recitation and Quiz Competition- SAMSRISHTI* on 10th January, 2018. A *Sanskrit Essay Writing Competition*, in collaboration with the Delhi Sanskrit Academy, was organized on 6th October, 2017. An educational excursion to the *National Museum* and *Kutub Minar* was organized for the students of Sanskrit department on 22nd September, 2017.

Department of Sociology conducted workshops and talks by eminent scholars, filmmakers and documentaries on a range of subjects like sexual exploitation of women, gender discrimination, Triple Talaq, and stress among college students, to name a few. The department signed an MOU with the University of Munster, Germany, on 31st January 2018 under the addon course on 'Safe Cities and Inclusiveness'. Such a course is being held in the University of Delhi for the first time. In addition to the coursework, the programme took a beyond-a-classroom approach where students were constantly pushed to engage with safety-audits to examine the neighborhoods of Delhi and examine how safe and secure women were. The program also offered internship opportunities to students in various collaborating organizations. Many students worked as interns with 181 helpline, DCW providing tele counseling and support to the victims of sexual abuse and violence.

1. By stander Intervention Programme

JDMC has entered into a collaboration with the University of Münster, Germany to conduct a Bystander Intervention Programme as a part of our vision to sensitise and empower our students.

The programme is conducted in the form of an eight hour workshop divided into 4 modules that include discussions on gender, patriarchy and also engage the students in role play exercises. This program aims to enable students to cope with and negotiate their social and cultural environment better as it also exposes them to their legal rights as women. Every first year student taking admission to JDMC will participate in this program and will receive a certificate from the two institutions on completion of the course.
