### Memorandum of Understanding

Mahatma Gandhi National Council of Rural Education (MGNCRE) Hyderabad (An Organization of Ministry of Education, Government of India)

This Memorandum of Understanding is made between Janki Devi Memorial College (University of Delhi), Sir Ganga Ram Hospital Marg, Old Rajinder Nagar, Rajinder Nagar, New Delhi, Delhi 110060 and Mahatma Gandhi National Council of Rural Education (MGNCRE) (an Organization of Ministry of Education, Government of India), Hyderabad.

#### 1. Purpose of MoU

The purpose of the MoU is to promote mutual cooperation in educational, training and research activities and establish a framework for programmes of exchange and collaboration in areas of Rural Development, Education, training, internship programmes and other areas of common interests for mutual benefit. This MoU would be applicable on mutual convenient and acceptable terms and conditions.

NOW THEREFORE, for furtherance of the objectives of both the organizations, and considering the long-term benefits of sharing the knowledge, resources and capacity by undertaking collaborative activities of research and extension, it is hereby agreed between Janki Devi Memorial College (University of Delhi), Sir Ganga Ram Hospital Marg, Old Rajinder Nagar, Rajinder Nagar, New Delhi, Delhi 110060 and MGNCRE as under:

#### • Joint Research Programme:

 Both the Council / institute shall work for joint and collaborative Action plan and consultancy in the thrust areas of common interests.

#### Joint Holding of /Workshop/Training/Symposia, etc

 Joint organization of workshops/ symposia/ training/lectures etc to improve the exchange of knowledge and experience.

#### Academic collaboration

o Institutions shall collaborate in common thrust areas and internship of students. They shall also be working together in the areas of Course development.

### • Online Training Programme

To encourage co-operation and interaction between inter-institution frequently conducted for wider academic understanding and exposure.

#### Exchange of Knowledge Resource Sharing

O Sharing of books, journals and teaching materials including textbooks, audio-videos, publications, reports and other teaching aids.

#### 2. EFFECTIVE DATE, DURATION, MODIFICATION OF MOU

- This MoU shall be effective from the date of signing and shall remain in force for a period of 12
  months from the said date. The duration may be extended with the consent of both the parties under
  mutually agreed terms and conditions.
- Unless otherwise extended by both the parties, the MoU shall be deemed to be terminated on expiry
  of the period mentioned above.

# 4. AMENDMENTS TO THE MOU

No amendment or modification of this MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be an amendment of this MoU. The modifications / changes shall be effective from the date on which they are made / executed unless otherwise agreed to.

### 5. ASSIGNMENT OF THE MOU

The rights or/and liabilities arising to any part of this MoU shall not be assigned except with the written consent of the other party and subject to such terms and conditions as may be agreed upon between the involved parties.

### 6. CONFLICT RESOLUTION

In the event of any dispute or difference between the parties hereto, such disputes or differences shall be resolved amicably by mutual consultation.
