- 3. The First Party through its coordinators would prepare the syllabus for the course in consultation with the resource person of the Second Party
- 4. The Financial aspects of this arrangement are agreed upon as under:
- a. 75% of the revenue generated will be paid to the Resource person conducting classes on behalf of ASPEUS.
- b. 25% of the remaining receipt after payment as above (if any) will be given to the First Party while the rest of the money will be credited to the Girl Up Nitara account.
- 5. Logos of both the parties will be used in the promotional material.
- 6. Both the parties have agreed that they will extend every form of co-operation to each other.
- 7. The First Party appoints Dr. Vibha Jain as Convenor, Ms. Bhawna Pal and Mrs. Amita Yadav as Co-Convenors for this course whereas the Second Party appoints Prof. Ramola Madnani as resource Person, who is also authorized to receive payment for conducting this course.
- 8. This agreement shall be made in two original copies, both of which would be equally valid. The First and Second parties will receive and hold one copy of this agreement.
